# 55<sup>th</sup> International Gas Conference GENERAL TERMS AND CONDITIONS OF CONTRACT

every natural or legal person user completing registration for the Event (hereinafter referred to as "User") regarding participation in the Event.

#### Legal Basis for the relationship between the Parties:

- Act No. V of 2013 on the Civil Code;
- Act No. CVIII of 2001 on Certain Aspects of Electronic Commerce Services and Services related to Information Society;
- Act No. CXII of 2011 on the Right of Informational Self-Determination and on Freedom of Information:
- Act No. CLV of 1997 on Consumer Protection;
- Act No. XLVIII of 2008 on the Basic Requirements and Certain Restrictions of Commercial Advertising Activity;
- Government Decree No. 45/2014 (II.26.) on the Detailed Rules of Contracts between Consumer and Company;
- Act No. LXXVI of 1999 on Copyright ("Copyright Act");
- Act No. XI of 1997 on the Protection of Trademarks and Geographical Indications ("Trademark Act"):
- Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the
  protection of natural persons with regard to the processing of personal data and on the free
  movement of such data, and repealing Directive 95/46/EC.

## Objective of Portal

The purpose of the Portal is enabling Users to register as participants or exhibitors of the 55<sup>th</sup> International Gas Conference after providing certain company and personal data, and providing information about the date, venue, topics, speakers, programmes of the Event, also recommending accommodation, and facilitating that registered Users can follow the conference presentations, roundtable discussions and other events online via the stream menu on the day of the event.

# Date and Venue of the Event

Date: 7-8 October 2025

Venue: BALATONFÜRED KONGRESSZUSI KÖZPONT (8230 Balatonfüred, Huray u. 3.)

Subcontractor performing technical organization: Lounge Event Kft.

#### Participation Fee, Exhibitor Fee

The User may register and utilize the services provided by the Organizer in connection with the Event as a participant or exhibitor, depending on their own decision. In both cases, the User must pay a fee, the details of which are outlined in the provisions below.

#### Participation fee:

- in early bird sales until August 22, 2025: HUF 214.500 + VAT,
- after August 22, 2025: HUF 260.000 + VAT.

The participation fee <u>includes</u> participation in the professional programmes of the Event, meals (coffee breaks, lunches, gala dinner) and participation in the evening programmes.

The participation fee does <u>not include with particular regard</u> the cost of accommodation, parking, and accessing the venue, or the cost of any extra consumption (other items not included in the event-related food and drink menu or the event-related food and drink offer). Each User is individually responsible for booking and paying for their accommodation.

The exhibitor fee shall be calculated using the unit prices of selected standard services, while in case of special requests, the fee is subject to a specific agreement between the Parties.

The exhibitor fee shall contain the following according to the selected exhibitor package:

Silver exhibitor and sponsor package with standard stand provided by the organizer (HUF 1.985.000 + VAT):

- participation in the professional programmes of the Event, meals (coffee breaks, lunches, gala dinner) and participation in the evening programmes for 3 persons,
- placement of company logo on conference notices, conference website and other conference related displays (e.g.: on-site display screens),
- 1 roll-up displayed in the event site,
- an 8m2 standard exhibition stand provided by the organizer.

Silver exhibitor and sponsor package with customized stand installed by the exhibitor (HUF 1.250.000 + VAT):

- participation in the professional programmes of the Event, meals (coffee breaks, lunches, gala dinner) and participation in the evening programmes for 3 persons,
- placement of company logo on conference notices, conference website and other conference-related displays (e.g.: on-site display screens),
- 1 roll-up displayed in the event site,
- provision of an 8m2 exhibition area with exhibition stand brought and installed by the sponsor. Gold exhibitor and sponsor package with standard stand provided by the organizer (HUF 2.650.000 + VAT):
  - participation in the professional programmes of the Event, meals (coffee breaks, lunches, gala dinner) and participation in the evening programmes for 3 persons,
  - placement of company logo on conference notices, conference website and other conference-related displays (e.g.: on-site display screens),
  - displaying the company intro video on on-site screens,
  - 1 roll-up displayed in the event site,
  - advertisement on the event website,
  - a 10m2 standard exhibition stand provided by the organizer.

Gold exhibitor and sponsor package with customized stand installed by the exhibitor (HUF 1.900.000 + VAT):

- participation in the professional programmes of the Event, meals (coffee breaks, lunches, gala dinner) and participation in the evening programmes for 3 persons,

- placement of company logo on conference notices, conference website and other conference-related displays (e.g.: on-site display screens),
- displaying the company intro video on on-site screens,
- 1 roll-up displayed in the event site,
- advertisement on the event website,
- provision of a 10m2 exhibition area with exhibition stand brought and installed by the sponsor. Platinum exhibitor and sponsor package with standard stand provided by the organizer (HUF 3.250.000 + VAT):
  - participation in the professional programmes of the Event, meals (coffee breaks, lunches, gala dinner) and participation in the evening programmes for 4 persons.
  - placement of company logo on conference notices, conference website and other conferencerelated displays (e.g.: on-site display screens),
  - appearance on the projection screen and on on-site display screens during the breaks between presentations,
  - 2 roll-ups displayed in the event site,
  - advertisement on the event website,
  - a 12m2 standard exhibition stand provided by the organizer.

Platinum exhibitor and sponsor package with customized stand installed by the exhibitor (HUF 2.350.000 + VAT):

- participation in the professional programmes of the Event, meals (coffee breaks, lunches, gala dinner) and participation in the evening programmes for 4 persons.
- placement of company logo on conference notices, conference website and other conference related displays (e.g.: on-site display screens),
- appearance on the projection screen and on on-site display screens during the breaks between presentations,
- 2 roll-ups displayed in the event site,
- advertisement on the event website,
- Provision of a 12m2 exhibition area with exhibition stand brought and installed by the sponsor.

With regard to any exhibitor and sponsor package, the exhibitor fee does <u>not include with particular regard</u> the cost of accommodation, parking, and accessing the venue, or the cost of any extra consumption (other items not included in the event-related food and drink menu or the event-related food and drink offer). Each User is individually responsible for booking and paying for their accommodation.

#### Registration Procedure, Conclusion of Contract

Registration for the Event is possible via the Event website (www.gazkonferencia.com) (Registration/Online Registration). Registration is carried out by filling in the application form and by accepting the Information Leaflets on Data Protection and the General Terms and Conditions of Contract (GTC). By clicking on the Send button (ticking the checkbox), User agrees to be bound by the provisions of the GTC. User receives an automatically generated system message to the email address provided during registration on the receipt of the registration by the Organizer, which shall not yet establish a contract between the Parties. The contract is concluded by and between the Organizer and the User when the amount of the proforma invoice, or invoice sent by the Organizer by email has been transferred to the Organizer and crediting it to the Organizer's bank account. Organiser will send a proforma invoice for registrations received by 19 September 2025, and an invoice for registrations received after 19 September 2025.

The contract between the Organizer and the Exhibitor shall be concluded upon receipt by the Exhibitor of the confirmation email sent by the Organizer to the Exhibitor's email address following the registration, which confirms the provision of the exhibition and its terms and conditions.

The contract shall constitute a participation contract concludedover the internet but not signed (in writing), the content of which shall be archived by the Organizer, accessible, retraceable, but accordingly not accessible on paper.

The contract for the publication (exhibition) of advertising shall be considered a written contract concluded via the internet. Upon receipt of the payment, the Organizer shall send the User an electronic document in PDF format to the User's email address. The content of the contract shall be archived by the Organizer in a manner that ensures it is accessible and retraceable, and as such, it shall not be available in paper form. In accordance with Act XLVIII of 2008, a contract for the publication (display) of advertising concluded electronically shall be deemed a written contract even if it has not been signed by the parties using an electronic signature.

User shall be responsible for the accuracy, veracity and completeness of the data submitted by the User during registration. Organizer shall not be held responsible for any damage arising from incorrectly submitted user data even if it could have detected such data inaccuracy.

#### **Payment Conditions**

Following registration, Organizer shall send a proforma invoice or invoice on the full amount of the participation fee. Having received the advance payment, Organizer shall send the prepayment invoice to the User, with a performance date corresponding to the date of receiving the advance payment on the bank account.

The due date of participation fee payment shall be the 15th (fifteenth) calendar day from the issue date of the proforma invoice, or invoice but not later than the business day preceding the Event date.

Following the realization of the Event, the Organizer shall issue an invoice to the Exhibitor for the full amount of the exhibitor fee. The exhibitor fee shall be payable within fifteen (15) calendar days from the date of the invoice.

Payment shall in any case be carried out by transfer indicating the proforma invoice, or invoice number in the comment field.

Participation in the Event shall be conditional on the payment of the participation fee.

Upon closing the Event, Organizer shall send the final invoice to the User, indicating the full amount and deducting therefrom the already paid advance payment. The fee for the meals shall be indicated separately on the invoice.

#### Modification, Cancellation of Registration

Modification of Event registration or cancellation of participation as User shall be sent to the Organizer in writing (by filling in the contact form available on the Event website, or by sending it to the email address: info@gazkonferencia.com).

Participation can be cancelled until 7 September 2025 free of charge.

In case of cancellations requested between 8-19 September 2025, the penalty for cancellation is 50% of the net participation fee/exhibitor fee, which shall be deducted from the already paid and refundable participation fee. By accepting this GTC, User shall expressly agree to such deduction. The bank account number required for the refund transfer shall be submitted when cancelling the participation.

In case of cancellations requested following 19 September 2025, a cancellation penalty equal to the net entry/exhibitor fee will be payable, i.e. the Organiser will not be able to refund the fee paid. Failure to participate in the Event shall not provide exemption from the obligation to pay the participation and/or exhibitor fee.

#### Cancellation of the Event

The Organiser reserves the right to cancel the Event, in whole or in part, at any time and without any obligation to pay compensation. The Organiser will notify Users of the cancellation of the Event by email and/or telephone. In so far as the Event is fully cancelled by the Organizer, the total amount without interest of the participation fee/exhibitor fee paid shall be refunded to the bank account number specified by the User, within 30 days of the bank account being provided.

#### Information on Data Protection

Organizer shall process personal data provided by the User as Data Subject, the list of which, together with the circumstances and conditions of data processing shall be contained in the document made available and accessible on the Portal under the title "Information Leaflet about Processing Personal Data for the Participants of the 55<sup>th</sup> International Gas Conference". The information leaflet about processing personal data in relation to technical use of the Portal shall be contained in the document made available and accessible on the Portal under the title "Information Leaflet about processing personal data related to using the website".

### Copyright

Content published on the Portal shall be the Organizer's intellectual property.

The use of any third party copyrighted content published by the Organizer (e.g.: quotes, photos, graphic contents, trademarks, logos, domain names etc.) shall in any case be subject to the Copyright Act and the Trademark Act. Any use beyond the above requires consent from the relevant author.

#### Miscellaneous

The official language of the Event is Hungarian. Organizer provides simultaneous interpretation into English for the professional programme of the Event.

Organizer reserves the right to modify the announced programme of the Event.

Organizer draws the User's attention to the fact that video/audio recordings may be made or photos may be taken of the event. Provided that during registration, by accepting the document "Information Leaflet about Processing Personal Data for the Participants of the 55<sup>th</sup> International Gas Conference", User as Data Subject explicitly consented to making recordings and taking photos, Organizer may use such audio and video recordings in printed and online materials and in the conference news reports, to which the above Information on Data Processing shall apply.

Organizer reserves the right to amend this GTC in part or in full at any time. Organizer shall inform the Users on GTC amendments on the website: www.gazkonferencia.com.

This contract shall be governed by Hungarian law. In case of non-consumer users, Organizer shall not be obliged to apply those provisions of these General Terms and Conditions of Contract which shall exclusively govern contracts concluded with consumers (Section 8:1 (1) 3 of the Civil Code) pursuant to the Civil Code or other rules of law with particular regard to Government Decree No. 45/2014. (II. 26.).

Organizer shall exclude its liability for any damage resulting from the unprofessional or illegal use of the Portal.

Regarding online operation of the Portal or the organisation of the Event, Organizer shall exclude its liability for any damage resulting from an external factor that cannot be foreseen or prevented (e.g.: force majeure).

Organizer expressly excludes its liability for any consequential damage. The Organizer's liability for damages shall be limited to not more than the application fee paid by the User, except if the rules of law expressly exclude the limitation of liability.

The parties confirm that Organizer as member of the Hungarian MVM Group, and its single-member and majority-owned subsidiaries shall not be considered as third parties in terms of the acquiring of trade secrets, that is, the Organizer is authorised to disclose to MVM Group subsidiaries any trade secret related to this contract, and MVM Group subsidiaries shall be authorised to utilise any trade secret thus acquired, even without any additional separate consent by the User.

User expressly agrees that MVM Services Zártkörűen Működő Részvénytársaság (registered office: 1081 Budapest, II. János Pál pápa tér 20.; company registration number: 01-10-048351) as the entity proceeding in respect of the performance of the contract and the management of the Organizer's invoices, as well as the duly authorised employees of the above company, may have access to the contract and become familiar with its contents. MVM Services Zrt. shall be bound by the same obligation of confidentiality as the Organizer in respect of data obtained and provided, and the Organizer shall be liable towards the User in the event of a breach of this obligation.

User consents to the Organizer's publishing, or, if both contracting parties are publicly owned companies, the Parties mutually consent to the other Party's publishing, its data included in this Contract and that are specified in Section 2(3) of Act CXXII of 2009 on the more economical operation of publicly owned companies (hereinafter: Economical Operation Act), where the value of the Contract or the combined value of all contracts on the same matter, entered into with the contractual partner in a fiscal year, reaches the threshold value referred to in Section 2 (3) of the Economical Operation Act.
